## NOTICE

### RAGGING UNLAWFUL ACTIVITY

1. **RAGGING** has been declared as an illegal activity inside and outside the Campus. Orders on the subject are very clear. All students are hereby cautioned not to indulge in these unlawful activities. Strict disciplinary action will be taken against default of the Orders banning Ragging within or outside the Institutional area.
2. Students found absent from their classes would also be presumed indulging in these activities, which may attract disciplinary action.
3. Watch and Ward Staff will ensure and stop the illegal entry of the personnel in the College Premises
4. Relevant AKTU Notification No. Dr. A.P.KJ(88/92/CB/Edc./PF/ dated January 2000 on the subject matter is reproduced below for information of all students and Staff.

#### **EXTRACT FROM CAMPUS NOTIFICATION ON RAGGING**

Ragging in any form shall be strictly prohibited within the premises of the institution, as the case may be, or in any part of the Institute system as well as on public transport, or at any other place, public or private.

Any individual or collective act or practice or ragging shall constitute an act or gross indiscipline and shall be dealt with under the provisions of this ordinance.

Ragging, for the purposes of this ordinance, shall ordinarily mean any act, conduct or practice by which the dominant power or status of senior students is brought to bear upon the students who are in any way considered junior or inferior by the former and includes individual or collective acts or practices which

- a. Involve physical assault or threat to use physical force.
- b. Violate the status, dignity and honour of students, in particular women students and those belonging to a scheduled caste or scheduled tribe;
- c. Expose students to ridicule or contempt or commit an act which may lower their self esteem; and
- d. Entail verbal abuse, mental or physical torture, aggression, corporal punishment, harassment, trauma, indecent gesture and obscene behaviour.

## ANTI-RAGGING RULES AND REGULATIONS

RAGGING MEANS	PUNISHMENT
a) Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.	1) Suspension from attending classes and academic privileges.
b) Including in rowdy or in undisciplined activities by any student or students. which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.	2) Withholding/withdrawing scholarship/ fellowship and other benefits.
c) Asking any student to do any act which such student will not in the ordinary course do and which has effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.	3) Debarring from appearing in any test/ examination or other evaluation process.
d) Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.	4) Withholding results.
e) Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.	5) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
f) Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.	6) Suspension/ expulsion from the hostel
g) Any act of physical abuse including all variants of it; sexual abuse, homosexual assaults, stripping, forcing obscene, and lewd acts, gestures, causing bodily harm or other danger to health or person.	7) Two years imprisonment.
h) Any act or abuse by spoken words, emails, posts, public insults, which would also include deriving perverted pleasure vicarious or sadistic thrill from actively or passively participating in the Discomfiture to fresher or nay other student.	8) Fine to the tune of Rs.2.50 lakhs.
	9) Cancellation of admission.
	10) Rustication from the institution for period ranging from one to four semesters.
	11) Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.

4) I hereby affirm that, if found guilty of ragging, my ward will be liable for punishment according to clause 9.1 of the regulations, without prejudice to any other criminal action that may be taken against my ward under any penal law or any law for the time being in force.

I hereby declare that my ward has not been expelled or debarred in admission in any institution in the country on account of being found guilty of, abetting or being part of a conspiracy to promote, ragging; and further affirm that in case the declaration is found to be untrue, my son/daughter's admission is able to be cancelled.


